Legislative Update Progress continues on our licensing bill, HB 339, following our interested parties meeting in February. The main focus from opponents is on new residential construction and definitions regarding “employee.” ACCO and PHCC Ohio have created (and sent to parties) language for the bill. We feel the language takes care of the issues and will result in moving the bill forward.

Other than HB 339, the following licensure bills have been introduced:

- HB 148 License Home Improvement Contractors
- HB 164 License Roofers
- HB 71 License Home Inspectors
- HB 236 License Elevator Contractors
- HB 504 License Interior Designers
- SB 115 License Roofers, Gutter and Downspout Contractors
